



# Diligent Urgent Care

For the health and safety of everyone in the Lutherlyn community, we are partnering with Diligent Urgent Care to offer COVID testing this summer.

We will be testing all campers and staff before arrival at camp using **at home PCR COVID tests and rapid antigen COVID tests upon arrival at camp**. A telemedicine appointment in advance is required in order to keep the process as streamlined as possible. Fill out the form at [www.lutherlyn.com/DUC](http://www.lutherlyn.com/DUC) and schedule your appointment starting **TODAY!**

The process is simple and is outlined below. We appreciate your compliance in keeping our camp community as safe as possible. As a reminder, this goes through insurance and there are no copays being charged for this service.

1. Call Diligent Urgent Care to schedule a telemedicine appointment at 201-834-8887 or [CLICK HERE](#)

- **PLEASE IDENTIFY YOURSELF AS A CAMP LUTHERLYN CAMPER OR STAFF**
- You will be asked for your insurance information
- You will be asked to pick a time to meet with a Physician Assistant **VIRTUALLY**
- Telemedicine is open and ready for you today. Appointment must be done **BEFORE** you arrive at camp. See below for telemedicine visit deadlines. Registrations submitted after the listed deadline must fill out the form at [www.lutherlyn.com/DUC](http://www.lutherlyn.com/DUC) and schedule your Telemedicine visit immediately.

2. You will receive an email and/or a text on the day of your appointment with a link to connect virtually with the Physician Assistant at your scheduled telemedicine appointment time.
3. At your scheduled telemedicine appointment, you will be asked a few questions about your possible COVID exposure.
  - **PLEASE IDENTIFY YOURSELF AS A CAMP LUTHERLYN CAMPER OR STAFF**
  - Parent or guardian must be present for anyone under the age of 18
  - Expect appointment to be approximately 5 minutes
  - Inform Physician Assistant that you are **required to have an at-home PCR AND a rapid antigen test during the first week** at camp
  - Confirm mailing address for at-home PCR test.
  - Physician Assistant will input an order for your at-home PCR test and Rapid Antigen test to be administered by a Medical Assistant at camp.
4. At-home PCR
  - An at-home PCR test will be shipped to you following your telemedicine appointment. Please call 201-834-8887 if the PCR test is not received within 10 days of your camp arrival day.
  - You will need to schedule your telemedicine appointment no later than the date listed below.
  - Swab and send your specimen back to the lab in the prepaid envelope on the specified date below.
  - Results will be emailed to you and provided to **Camp Lutherlyn**.

5. Day of Arrival Testing:

- Arrive at camp at the time designated by Lutherlyn
- Check in at the COVID testing desk
- Confirm your name
- Medical assistant will perform the rapid antigen test by doing a nasal swab
- Results will be available within 15 minutes
